### PRESENTATION: NOT TOUGH ENOUGH: THE CASE FOR RESILIENT SEISMIC DESIGN

ASCE 7's life-safety seismic objective bakes catastrophe into the building stock. A large earthquake like a M<sup>w</sup> 7.8 Southern San Andreas earthquake or M<sup>w</sup> 7.0 Hayward Fault event could cause shaking approaching or exceeding MCE<sup>s</sup> across thousands of square kilometers. If we get exactly the performance the code assumes, that earthquake could cause 10,000 code-compliant buildings to collapse and 500,000 to be red- or yellow-tagged in either metropolitan area. In the Bay Area, that would amount to 1 in 4 buildings, enough to produce outmigration like New Orleans after Katrina. Alternatively, ASCE 7 could drop the 2/3 factor in two design equations to make new buildings 50% stronger. Doing so could reduce damage to the extent that 95% of people could shelter in place in the Big One. The change would raise building cost about 1%, as opposed to the much larger cost to retrofit existing buildings to achieve the same end. A first-of-its-kind survey finds that the public expects and would willingly pay for such resilient buildings. Leading engineering ethicists find that ASCE's Code of Ethics requires ASCE 7 to reflect those preferences in design. But cities need not wait for ASCE 7 and the ICC to agree. They can adopt the IBC with a 1-sentence modification and start building the resilient building stock that the public expects.

Keith Porter, PE PhD  
University of Colorado Boulder

Dr. Porter is a Research Professor in Structural Engineering and Structural Mechanics at the University of Colorado Boulder and Principal of SPA Risk LLC. He specializes in risk from natural disasters and 2nd generation performance-based earthquake engineering. Notable works include the 4:1 natural-hazard benefit-cost study for the US Congress, the San Francisco Community Action Plan for Seismic Safety's soft-story study, and the engineering risk analyses of the USGS' ShakeOut, ARKStorm, Tsunami Scenario, and HayWired Scenario. He is a licensed Professional Engineer and author of 170 scholarly and professional works.

## BUILDING CODES AND STANDARDS COMMITTEE

Upon the SEAOSC new fiscal year beginning in July, the Building Codes and Standards Committee leadership changed to Co-Chairs Michael Ciorte, Supervising Structural Engineer for DSA, and Colin Kumabe, Metro Plan Check Chief for the City of LA. We intend to expand the scope and depth of activity of this important committee. This Committee researches local, state, and national code, standard, ordinance and policy proposals and/or changes. Then it periodically disseminates information on timelines and proposals and/or changes to the membership and solicits input, develops proposals and/or positions, and engages with the SEAOC code committees to improve the success potential for changes or positions developed for national codes and standards. Our action plan follows.

- a) **Outreach:** Outreach to engineers with expertise in the development of the national building codes and national standards (e.g., IBC, IRC, IEBC, ACI 318, AISI S100/S200's, AISC 341/358/360, ASCE 7, AWC NDS/SDPWS, TMS 402, etc.) as well as with expertise in the California Building Code. Also to outreach to engineers who work in the area of code enforcement and interpretation including city, county, and state jurisdictions. Last, but certainly not least, it is vitally important to get participation of design engineers, as that is where the comprehension and practicality of the requirements are tested and ideas for improvements are often formed. Please participate if you have strong opinions and ideas to improve any codes, standards, ordinances, or policies.
- b) **Research:** Research and develop national code and standard proposals and timelines as well as local and state codes, ordinance, and policy proposals and timelines.
- c) **Dissemination:** Periodically disseminate the information to the membership to inform and solicit feedback.
- d) **Meetings:** Hold monthly teleconference meetings and at least two face to face meetings throughout the fiscal year, with specific topics of discussion, and maintain summary of the status or resolution of past topics.
- e) **Participation:** Allow the broadest participation of the members at large (not just the Committee), as is possible, in the code, standard, ordinance, and policy writing and proposal process by having (among other things) a cloud-based electronic service where comments are posted, reviewed, and addressed.
- f) **Knowledge:** Make the code and standard development process widely known across the SEAOSC membership, such as to give every member the chance to provide timely and adequate input so they may have a better chance at influencing the outcome. In our opinion, there seems to be a general feeling that the code and standard writing process is an arcane undertaking, difficult to influence, and we end up with whatever comes from 'above'. We would like to change this, precisely because it is indeed a rather complex process that can only be taken on successfully if we are informed and have wide participation from those with a variety of experience.

This committee has great potential for participants to improve the requirements our profession follows, the understanding of these requirements, and the built environment for our communities. We are seeking those who are interested and would like to contribute some of their time and expertise to make a difference. Please email Co-Chair Michael Ciorte at [Michael.ciorte@dgs.ca.gov](mailto:Michael.ciorte@dgs.ca.gov) if you are interested. For those who are interested in participating, the Committee's first teleconference meeting will be on **August 18<sup>th</sup> at 4:00 pm**. The agenda will be e-mailed to all those who have shown interest. The agenda will cover the timeframes and the entities involved in the development of the relevant upcoming codes and standards provision change cycles, including the 2018 I-Codes, as well as the Committee charges and membership.

## WOMEN IN STRUCTURAL ENGINEERING TASK GROUP

If you've read Michelle Kam-Biron's past President's message, you're aware that there has been an interest in creating a group to support women in structural engineering. With the help of Lorena Arce, Michelle Kam-Biron, Annie Kao, Victoria Wigle and Kirsten Zeydel, SEAOSC now has an official SEAOSC group under the Membership Committee with the title of "Women in Structural Engineering Task Group" and there are about sixty women who are interested in participating in this group. On July 7th, Lorena Arce, Michelle Kam-Biron, Annie Kao, and Kirsten Zeydel had lunch with the AIA-Los Angeles Women in Architecture Committee leaders (see below) to see if there is some synergy between our groups and the potential of working together toward common goals.



The Task Group is in the initial stages of planning two events:

- Panel discussion possibly on Diversity/Women for the SEAOSC March 1<sup>st</sup> Dinner meeting.
- In conjunction with the Orange County SEAOSC Directors, hosting a speaker that will discuss diversity in the business world and possibly prior to the meeting a round table discussions with younger female engineers.

There may also be some impromptu gatherings in LA and OC. The Task Group is excited to be moving this effort forward and would like to invite all of you to join us before the **September 7<sup>th</sup> SEAOSC Dinner meeting at 4:30 pm** ([click here](#) for info) where we will be starting the discussion about charges and planning for the events. ## IN THE NEWS

### SEAOSC Advises City of West Hollywood's Regarding Seismic Retrofit Ordinance

In late June, the City of West Hollywood requested that SEAOSC provide expertise in an advisory capacity to review technical standards for potential seismic retrofit ordinances that they are currently developing for the following buildings types: Wood-Frame Soft-Story Buildings, Wood Cripple Wall Buildings, Non-Ductile Concrete Buildings, and Pre-Northridge Welded Steel Moment Frame Structures.

In response to the City's request and tight timeline, SEAOSC assembled a small targeted advisory task group to review the proposed ordinances. The goal of the group was to provide technical feedback based on their past experience and knowledge of current and upcoming codes and standards. The City reviewed the members advice and incorporated as many of the recommendations as possible considering the boundaries of the proposed seismic retrofit program. Members of the advisory task group included David Funk of John Labib + Associates, Jonathan Buckalew of Nabih Yousseff, Josh Gebelein of Brandow & Johnston, Michael Cochran of Thornton Tomasetti, and Michael Mehrain of MNI. Daniel Zepeda of Degenkolb Engineers acting as the consultant liaison between SEAOSC and the City of West Hollywood. The City is in the process of finalizing their seismic retrofit ordinances and is expected to present them to their city council in the month of August.

SEAOSC is appreciative of having been given the opportunity to offer advice to the City for these ordinances that will promote seismic safety in our communities. If any member of SEAOSC is interested in participating as an advisor in similar future efforts, please contact the SEAOSC office and express your interest.

### Mayor Garcetti Appoints New LADBS General Manager

On June 20, 2016, Los Angeles Mayor Eric Garcetti announced that Frank Bush will be the new Los Angeles Department of Building and Safety's (LADBS) General Manager. Frank has served with the LADBS for 27 years and previously served as Executive Officer, which is the second-ranking position for the agency. Formerly Raymond Chan held the position and is now the Interim Deputy Mayor for Economic Development. On August 3<sup>rd</sup>, the Los Angeles City Council confirmed Mayor Garcetti's appointment of Mr. Bush by a vote of 14-0. SEAOSC would like to offer our sincere congratulations to Mr. Bush and we look forward to continuing our long and strong relationship with the LADBS to ensure the safety and resilience of our communities!
